WHEN THE TIMES ARE CLOUDY AND MORE PEOPLE FEEL THE CHILL, WE MAY WONDER TO OURSELVES, "WHAT CAN I DO?" WE'RE NOT HEROES. AS LAWYERS, THERE'S MUCH WE CAN DO. THE VOLUNTEER LAWYERS PROGRAM PROVES IT YEAR AFTER YEAR. WE HELP THE LAW HELP THOSE WHO NEED IT.

It's a big challenge. Our nine counties cover 33,000 square miles, from Apache and Navajo reservations in the north to the border communities of Cochise and Santa Cruz. Our clients speak many languages, live in many geographies and represent many, many cultures.

Right now they need us more than ever. The national economic downturn has hit us hard. Effects include predatory lending. Debts related to health care costs. Unemployment benefits. Foreclosures. Bankruptcy. Spikes in domestic violence. As our state population grows, poverty grows with it.

Thankfully, our program has grown, too. Our 2008 recruitment campaign was our most successful yet. And we continue to offer more services.

We've added outreach clinics, including rural locations focused on Spanish speakers. We've also cultivated community partnerships. With the Community Foundation for Southern Arizona, for example, we helped launch a new HIV/AIDS project to draft wills and help prepare advance directives.

While we've increased service, we've also worked to improve it.

There's better project evaluation. Increased training for staff and volunteers. Input from partners such as the law school and the Court that helps us monitor the quality of our work and make changes when called for.

Part of our mission is to make the volunteer experience meaningful and valuable. That's especially true for students. This year, we opened an intake clinic where law students help clients resolve domestic relations and landlord-tenant issues. We now have opportunities for undergraduates and even began high-school internships.

Next year and beyond, we will strive to do more good for more clients and more volunteers. To them and you, to all who've been part of the VLP in 2008, we give our thanks.

Because of you, there's a little more justice in Arizona.

Heather Strickland began volunteering as a law student and hasn't stopped. Back in the summer of 2003, she assisted clients seeking Chapter 7 bankruptcy protection.

Since then, her work has come full circle. Part of our Child Support Project, now she's the mentor helping students assist unrepresented litigants through divorce proceedings.

Dean Christoffel has worked with the VLP for 27 years. He's taken on more than 400 cases directly and accomplished even more.

Dean had an idea for mobile clinics, a "traveling show" to serve remote areas. A month later, Pinal County saw its first domestic relations clinic. One Saturday, Dean drove almost 190 miles to recruit volunteers at the Sierra Vista Bench and Bar Meeting. He then wrote letters to every attorney who attended.

The passion and generosity of both Heather and Dean impress all who know them. Now you know them, too.

A bit of expertise.

This year, we continued to expand our reach into rural communities who can greatly use our help.

Based in Tucson, the VLP serves clients with civil legal matters in Apache, Cochise, Gila, Graham, Greenlee, Navajo, Pima, Pinal, and Santa Cruz Counties. In order to serve clients in the rural areas (outside of Pima county), the VLP actively recruits and trains attorneys from those counties. In addition, some rural cases are referred to attorneys who reside and practice in Pima County.

Cary Inabinet has been a big part of these efforts. He's performed pro-bono work for over 20 years, moving from Maricopa to Cochise County. Two of his pilot programs have helped more than 430 clients over the last seven years. Not only does Cary service clients directly, he's part of the VLP Advisory Board and works on both volunteer recruitment and training.

In the first quarter of 2008 the VLP expanded services to clients in need of assistance with domestic relations issues. The program expanded self-help clinics to domestic relations and domestic violence clients who reside in Cochise, Pinal and Santa Cruz Counties. In Cochise and Santa Cruz Counties the program expanded services by launching self-help clinics for monolingual Spanish speakers. In Pinal County the VLP held the program's first domestic clinic in February and continued to schedule them throughout the year.
